PRIVACY INFORMATION NOTICE

This information notice is provided pursuant to European Regulation 2016/679 on personal data protection in relation to data collected and processed by the ECU/LEO (Electronic Control Unit) as collector of the control units installed on Pagani vehicles.

The ECU/LEO Control Unit makes the vehicle data accessible to various parties: to the vehicle owner through the Mobile Application, to Pagani and the group companies, and to Pagani's partners (particularly, the approved service centres). These parties can view the vehicle's telemetry data via Wi-Fi, Bluetooth or via remote connection thanks to the data SIM card inside the control unit itself.

DATA CONTROLLER

The data controller is Pagani Automobili S.p.A. ("Pagani"), with registered office in Via dell'Artigianato no. 5, Vill. La Graziosa - 41018 San Cesario Sul Panaro (MO), Italy, Tel. +39 059 4739201 - Fax +39 059 927377, email address: info@pagani.com

DATA TRANSFER

Some data may be shared with recipients located in countries outside the European Union or the European Economic Area, also following their entry in databases handled by third companies operating as Data Processors, for technical and operational purposes and/or to ensure high service continuity.

Pagani ensures that the processing of the Data by these persons is subject to the purposes for which they were collected, and will be carried out in compliance with applicable laws. Therefore, in the event of transfer of Data outside the European Economic Area, Pagani will take all appropriate and necessary contractual measures to ensure an adequate level of protection, including – inter alia – adequacy decisions, agreements based on the Standard Contractual Clauses approved by the European Commission and any other guarantee useful to ensure that the level of protection of natural persons guaranteed by EU Regulation 2016/679 is not compromised. DATA COLLECTED

The ECU/LEO Control Unit collects the parameters detected by the control units installed on the Pagani vehicle, such as telemetry data and vehicle status data. In particular, data referring to speed, mileage, battery, electronic system functions, installed software version, safety data (such as airbags, seat belts, EDR) and, in general, telemetry data of the Pagani vehicle where the ECU/LEO Control Unit is installed are processed.





The Data Controller processes the telemetry data and other vehicle data together with additional details regarding the data subject (such as name, surname, email address, VIN (vehicle identification number), contact details, etc..) which may already be in its possession as a result of pre-contractual and contractual agreements which the data subject is a party to.

DETAILS ON PERSONAL DATA PROCESSING

The data are processed by the ECU/LEO Control Unit for the following purposes and according to specific legal bases, in accordance with the principles set out in art. 5 of EU Regulation 2016/679.

1. Performance of statistical and predictive tests

The data processed by the ECU/LEO Control Unit of the Pagani vehicles are processed in an automated manner by the Controller, in order to perform statistical and predictive tests on any existing or foreseeable damages or anomalies, on the basis of recurring situations encountered over time.

This also allows Pagani to obtain useful data and information for improving and developing its products.

2. Improvement of assistance quality

The data processed by the ECU/LEO Control Unit of Pagani vehicles are made accessible and available to persons belonging to Pagani's sales and service network. This allows Pagani Automobili to view vehicle status information, remotely and in real time, and so improve the quality of the assistance it provides.

3. Delivery of Services to Pagani Application Users

If the data subject has installed the Pagani Application on his/her own mobile device and has logged in using the credentials provided directly by the Controller, he/she can view the vehicle status information processed by the ECU/LEO Control Unit, perform any recommended actions, such as updating the control unit software, sending requests for assistance in case of vehicle breakdown or anomalies detected, and performing rapid actions on the vehicle.

For further information on the Pagani Application and its Services, please read the Terms of Use of the Application.

The processing of certain vehicle data by the ECU/LEO Control Unit is subject to consent by the data subject, for the directly related purposes indicated above. In these cases, consent may be withdrawn at any time, without prejudice to the lawfulness of the processing based on consent prior to withdrawal and without such withdrawal leading to any detrimental consequences for the data subject.

The data provided by the data subject and those processed by the ECU/LEO Control Unit are in any case necessary for performing a contract which the data subject is a party to or for implementing pre-contractual measures taken at his/her request. The provision of data for the above purposes is optional, but in the event of failure to provide the data or of the provision of incorrect data, Pagani will not be able to perform its contractual obligations insofar as they are related to the data processed.

Some data may be processed in accordance with current legal obligations.





RECIPIENTS

The Data will be brought to the attention or shared with Pagani Group Companies also located in countries outside the European Union and with duly appointed Pagani personnel.

The data will also be communicated to persons duly designated as data processors by virtue of a contract or other legal deed entered into with Pagani (for example, companies dealing with the management of IT systems and services, service and consultancy companies insofar as necessary for performing their tasks at Pagani, etc.). The data will also be communicated to or brought to the attention of companies belonging to Pagani's sales and service network, also located in countries outside the European Union, in order to provide the services made available by the Application.

Finally, the data will be communicated, if requested, to the competent financial offices and/or other Public Administrations, in accordance with the provisions of applicable laws. In particular, if the Pagani vehicle is registered in the United States, the Controller shall provide the California Air Resource Board (CARB) with the IUMPR data, the vehicle identification number (VIN) and diagnostic data, in accordance with legal requirements. The dissemination of any personal data being processed is in any case excluded.

The Data Controller will not disclose information about data subjects to third parties without their consent, except where required by law.

DATA PROCESSING METHODS

Personal data shall be processed using automated and manual means and for the time period strictly required to achieve the purposes for which such data have been collected.

As soon as the personal data are no longer necessary for the purposes for which they were collected, the Data Controller will delete them unless they must be archived according to the law or unless the User has agreed that the data be processed for a longer period of time.

In particular, personal data that have been collected are kept for a period of time identified by taking into account criteria such as the existence of a contractual agreement between the parties, or the User's continued consent, unless other data storage periods have been established.

Special security measures, listed in the Register on data processing operations, are observed to prevent data loss or illegitimate or improper use as well as unauthorised accesses to such data.

RIGHTS OF THE DATA SUBJECT

In accordance with articles 15 - 22 of EU Regulation 2016/679, rights are granted to all data subjects.

Right of Access: In accordance with art. 15, the data subject has the right to obtain confirmation that personal data concerning him/her are being processed and, where appropriate, to obtain a copy thereof. The data subject also has the right to obtain access to personal data concerning him/her and to further information such as the purpose of the processing, the categories of recipients, the data retention period and the rights that may be exercised. Right to rectification: the data subject, pursuant to art. 16, has the right to obtain the rectification of inaccurate personal data that concern him or her or completion thereof.

Right to erasure: the data subject has the right to obtain the erasure of personal data concerning him/her, without undue delay, should one of the grounds envisaged by art. 17 apply.

Right to restriction of processing: in the cases envisaged by art. 18 of Regulation 2016/679, the data subject has the right to obtain restriction of processing.

Right to data portability: the data subject has the right to receive the personal data concerning him or her in a structured, commonly used and machine-readable format, and has the right to transmit those data to another controller without hindrance, according to the provisions of art. 20 of Regulation 2016/679;





Right to object: the data subject has the right to object to processing of personal data concerning him or her according to the provisions of art. 21 of Regulation 2016/679. The data subject also has the right to lodge a complaint with the competent Supervisory Authority: the Privacy Authority.

Requests to exercise the above rights must be made in writing to the Data Controller and sent to privacy@pagani.com

The Data Controller will respond promptly to any requests to exercise data subjects' rights, within the timeframe established by current legislation.

Any further explanation or request for clarification may be submitted in writing to the Data Controller.

UPDATES AND AMENDMENTS

The Data Controller reserves the right to amend, supplement or periodically update this Information Notice in accordance with applicable legislation or the provisions adopted by the Data Protection Authority. The above amendments or supplements will be brought to the attention of the data subjects via e-mail. All data subjects are in any case invited to read the Privacy Policy on a regular basis to take note of any updates or amendments.
